Sr Haji Adzman invited the attendees for a moment of silence to pay our respect to the passing Committee member, Allahyarham Sr Faiyaz Ahmad Bin Maruf on 18th August 2021. Sr Haji Adzman also thanks to all members that attended the MIPFM 10th AGM despite the challenging period of the Covid-19 pandemic. He adds it has not been an easy journey for the last 2, members that attended today's AGM have shared commenced roles to elevate our profession.

Sr Haji Adzman takes the opportunity to wish the MIPFM members a Happy 10th Anniversary, he recalled the 1st Protem meeting was held on 30th April 2011 and the 1st MIPFM AGM was held on 12 May 2011. He also recalled the effort to get Property Managers services to be recognised as an Essential Service during the first Movement Control Order (MCO) period and the current year continues to be more challenging with the high numbers of Covid-19 infections, management office also affected and has to be closed and some of MIPFM members has also been infected with the Covid-19 besides the financial difficulties. 2. CONFIRMATION MINUTES OF THE PREVIOUS AGM

Sr Nageswaran briefly presented the minutes of the previous AGM and informed the audience that a copy of the minutes is available to be downloaded on the MIPFM website.

Minutes of the 9th AGM were tabled and discussed.

Being no further comments by members, Sr Hj Ishak Bin Ismail (PMF 0017) proposed to accept and adopt the minutes and seconded by Datuk Sr Haji Kamarulzaman bin Mat Salleh (PMF 0020).

REPORT OF THE COUNCIL FOR 2020/2021

Sr Nageswaran presented the MIPFM report for the term of 2020/2021. The following items were briefed:

1) Office Bearers for 2019/2021

Pictures and the names of the Committee appointed for the term 2020/2021 were displayed. Ten (10) nos. of Committee meetings were held for the term and other additional meetings on specific matters. All meetings had a quorum with the majority of committees being present. MIPFM currently has two (2) members of staff.

2) Allocation of Portfolio

Seven (7) portfolio has been assigned to each Committee such as Membership & Recruitment, CPD & Training Program, Conference & Annual Dinner, Newsletter & Publication, Press / Media, Collaboration & Partnership and SOP & Professional Certification Program. The allocation of the portfolio was tabled and all committees have their specific duties.

3) Membership

MIPFM has 900 active members with an increased number of Fellow, Ordinary and Associate Members in the year 2021. MIPFM also has terminated some of the members due to unpaid membership fees. 58 members are in default for three (3) consecutive years (2018, 2019 and 2020) and 125 members have not

paid their membership prior to 2021. Sr Nageswaran reminded members who attended these AGM to remind their friends or colleagues that also a member of MIPFM to pay their membership subscription.

4) Report on Activities

i. Workshop for the Registration of Real Estate Negotiators (REN)

MIPFM continued the collaboration with IM Global Property Consultants Sdn Bhd in organising a series of workshops for the Registration Real Estate Negotiators (REN) for the year 2020. Based on the 40% profit sharing. The total amount earned by MIPFM for the year 2020 was RM 3,127.20.

ii. CPD Seminar: MIPFM Seminar Series 2020 'Proactive Property Manager'

The full-day seminar series has received 5 CPD Hours from the Board of Valuers, Appraisers, Estate Agents and Property Managers Malaysia (BOVAEP). The seminar series was sponsored by Nippon Paint Malaysia. The speakers for this seminar series are Datuk Sr Hj Kamarulzaman, Sr Siew Yee Hoong, Sr Haji Ishak Ismail and Sr Matthias Loui. The half-day webinar was held on 12 January 2021 and has received 3 CPD Hours from the Board of Valuers, Appraisers, Estate Agents and Property Managers Malaysia (BOVAEP). The speakers for this webinar are Tuan Ahmad Nazri Bin Ab Kader from the Department of Occupational Safety And Health (DOSH) and Tuan Mohd Haikal Bin Md Kasri from the Fire and Rescue Department of Malaysia (BOMBA). This webinar was moderated by Sr Haji Adzman Shah.

iv. MIPFM 5th Conference 2021 (Webinar): Best Practice in The New Norm for Property Management MIPFM 5th Conference 2021 was the first MIPFM conference conducted through Webinar. It was held on 25 March 2021. Sr Haji Adzman Shah was the moderator for the Conference and MIPFM has invited international and local speakers to share their knowledge and experiences in the Property and Facility Management aspect. The speakers for the conference are Datuk Sr Hj Kamarulzaman, Ar. Anthony Lee Tee, Mr. Sathish Rajendren, Ms. Irene Lim. The conference is sponsored and supported by Nippon Paint (M) Sdn Bhd and CSS Decisions Sdn Bhd.

5) The Property Manager (E-Journal)

The Property Manager e-journal was published to members and has come to the 7th edition. Professor Sr Ts Dr. Ting Kien Hwa has taken lead in the publication of the Property Manager e-journal as the Editor-in-Chief. Various topics and information have been published including the current issues. Sr Nageswaran hopes members will take the opportunity to read the e-journal and this will be continued for the benefit of the members.

9) MIPFM'S Activity Report During Full Movement Control Order (FMCO)

MIPFM actively issued circulars to the members during the Covid-19 Pandemic to ensure members received the latest update during the Full Movement Control Order (FMCO) and to ensure members are clear with the directive of the SOPs and others.

10) Royalty from CSS Decision Sdn Bhd

MIPFM continues to receive royalty payments from CSS Decisions Sdn Bhd. Based on the MOU signed in 2012, MIPFM will receive a 5% royalty payment for each of its members subscribing to CSS Decisions software. The total amount received for 2020 was RM 54,588.03. Sr Nageswaran said from the royalty received it is shown that CSS Decisions still being a popular application among Property Managers.

MIPFM has contributed the amount of RM 5,000.00 as the contribution aid to Malaysia Agro Exposition Park Serdang (MAEPS) Covid-19 Integrated Quarantine and Treatment Centre (PKRC), Kajang Hospital and Serdang Hospital. This is a joint CSR Program with PEPS and the other professional bodies.

Comments from members:

Question: Tan Sri Dato' Dr. Sr Abdul Rahim inquired about the rules regarding defaulters and how long do MIPFM allow those defaulters to continue being MIPFM members?

Answer: Sr Adzman answered Tan Sri Dato' Dr. Sr Abdul Rahim question that the members have a maximum of 3 years in defaults before their membership is terminated. We have a total of 67 members who have been terminated due to unpaid membership subscriptions.

4. AUDITED ACCOUNTS REPORT

Sr Siew Yee Hoong, Treasurer General presented the Audited report for the year ended 2020. MIPFM Accumulated Fund for 2020 has increased from RM 363,105.32 to RM 411,611.84 and MIPFM Current Assets for 2020 have increased from RM 394,322.83 to RM 457,035.08. Sr Siew said despite the Covid-19 Pendamic, MIPFM still managed to have a surplus of RM 48,506.52 for the year 2020. MIPFM has increased the Fixed Deposit amount in the year 2020 from RM 262,968.35 to RM 387,775.17. Sr Siew briefly explained the table of Statement of Financial Position, Income and Expenditure. Sr Siew also thanks to the Secretariat for the increment in the membership collection. Besides that, the increment from the CSS Royalty.

Being no further comments by the members, Sr Tan Hoon Tiong (Billy) (PM 0699) proposed to accept and adopt the accounts for the year 2021 and seconded by Sr Haji Mohd Khairudin Abd Halim (PFM No. F0023).

5. PROPOSED AMENDMENTS TO THE CONSTITUTION

Sr Haji Adzman presented the three (3) proposed amendments to the constitution as below:-

Being no further comments and objections by the members, unanimously have agreed to pass Motion 1.

Motion 2: To Appoint an Honorary Legal Advisor.

To appoint an Honorary Legal Advisor for MIPFM for providing advice to MIPFM on legal matters which require a legal opinion and any necessary action thereafter. The Committee shall be given the mandate to appoint the Honorary Legal Advisor based on their discretion.

Resolution: To resolve as follows, the Committee shall be given the mandate to appoint the Honorary Legal Advisor based on their discretion.

Being no further comments and objections by the members, Sr Victor Huang Hua (PM 0592) proposed to accept and adopt Motion 2 and seconded by Mr. Oh Kian Shen (PM 0756).

III. Proposal: To (a) approve the use of a Prefix for "Property Manager" for Members of MIPFM who are also Registered Property Managers (b) to seek the concurrence of BOVAEP for the use of the selected Prefix by Prof Sr Dr. Ting Kien Hwa

In line with other professional bodies that have prefixes eg Sr, Ar, Ir, etc for its members. Members of MIPFM refer to Ordinary Members and Fellow Members of MIPFM who are eligible to use the prefix Members who use the prefix need to be Registered Property Managers with the Board of Valuers, Appraisers, Estate Agents and Property Managers.

This prefix once approved by Members in this AGM is however subject to concurrence by the Board of Valuers, Appraisers, Estate Agents and Property Managers.

Comments from members:

- Sr Haji Adzman reminded members to be careful and to avoid the prefix being abused. He said if the proposal is passed and approved by the BOVAEP, MIPFM has to tighten the clause.
- Sr Haji Ishak also shared his concerns as in Motion 1, we have allowed Associate Members to be upgraded to Ordinary Members after 3 years of being MIPFM members and the Associate Members are not Registered Property Managers. He suggested to control the use of PMgr prefix to avoid any confusion.
- > Y8 Tan Kok Yew suggested to make an official proposal to the government for them to recognise the Property Managers officially in government protocol.
- Sr Haji Adzman answered to YB Tan Kok Yew's suggestion, that Prefixes are only allowed to be issued by the Institution.





NOTES TO FINANCIAL STATEMENTS - 31st December, 2021

1. ORGANISATION AND OBJECTIVES

- (a) General information:-
 - (i) The Institute is registered under the Societies Act, 1966 with the registered address at No 64-66, Jalan 52/4, Petaling Jaya 46200, Petaling Jaya, Selangor.
- (b) The Institute is a non-profit making organisation with the following main objectives:-
 - (i) To promote the role of Property Managers, Asset Managers and Facilities Managers in Malaysia as well to respect and uphold the integrity of the profession of Property Managers and its Governing body, the Board of Valuers, Appraisers & Estate Agents Malaysia.
 - (ii) To upkeep and promote the development of the profession of Property Managers, Asset Managers and Facilities Managers through active participation of the affairs of The Royal Institution of Surveyors, Malaysia (RISM) and the Persatuan Penilai, Pengurus Harta, Ejen Harta & Perunding Harta Swasta Malaysia (PEPS) and common representation in the governing body.
 - (iii) To provide a forum for the promotion of any cause common to the business interests of members.
 - (iv) To foster, maintain and preserve the integrity and status of members of The Institute, to sustain honourable practice, to discourage malpractice and to encourage actively strict observance of the Code of Ethics and the Code of Professional Conduct prescribed by the Institute.
 - (v) To promote, research and encourage the members of the Institute to keep abreast with latest developments relating to the practice of property management, asset management, facilities management or any of its allied subjects.
 - (vi) To maintain and make available to the public an up-to-date list of members of the Institute.
 - (vii) To acquire, sponsor, promote, organize, conduct, manage or finance or assist in the acquiring, sponsoring, promoting, organizing, conducting, managing or financing of exhibitions, trade fairs, stands or displays or other commercial ventures that are related to the objects of the Institute whether as principals or jointly in partnership with any person, company, or Institute.
 - (viii) To acquire and own real estate for use of the Institute in line with its objectives.
 - (ix) To enter into strategic partnership with third parties or to form or incorporate subsidiary companies in furtherance of the objects of the Institute.

1. ORGANISATION AND OBJECTIVES (continued)

- (b) The Institute is a non-profit making organisation with the following main objectives (continued):-
 - (x) To set up and maintain a panel for the appointment of arbitrators, mediators and adjudicators for the resolution of disputes that are in the areas of competence of Property Managers, Asset Managers and Facilities Managers to resolve as arbitrators, mediators and adjudicators.
 - (xi) The income and property of the Institute shall be applied solely towards the furtherance, promotion and execution of the objectives of the Institute and no portion thereof shall be paid by way of dividend to the members, that nothing herein expressed or contained shall prevent the payment in good faith of remuneration or expenses or both to any Member or Officer of the Institute or other person or persons for services actually rendered by him or her or them to the Institute.
 - (xii) To promote education and training and to hold examinations to qualify members of the Institute.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting

The financial statements of the Institute have been prepared in accordance with Malaysian Private Entities Reporting Standard ("MPERS") and the requirements of Societies Act, 1966 in Malaysia.

(b) Plant and equipment

(i) Measurement basis

Plant and equipment is stated at historical cost less accumulated depreciation and any impairment losses. The plant and equipment comprises their purchase prices and any directly attributable costs in bringing the plant and equipment to working condition.

Plant and equipment retired from active use and held for disposals are stated at the lower of net book value and net realisable value. Gain and loss on disposal of plant and equipment is determined by references to its carrying amount and is taken to the income statement in the financial year in which it was disposed.

(ii) Depreciation

Plant and equipment are depreciated on a straight line basis over their estimated useful lives. The principal annual rates used are as follows:-

(c) Receivables

Receivables are stated at nominal value as reduced by the appropriate allowances for estimated irrecoverable amounts. Known bad debts are written off and allowance is made for any specific receivables considered to be doubtful of collection.

(d) Payables and Provisions

Payables are carried at cost which is the fair value of the consideration to be paid in the future for the goods and services received.

Provisions are recognised when the Institute has a present legal or constructive obligation as a result of past events, when it is probable that an outflow of resources will be required to settle the obligation, and when a reliable estimate of the amount can be made.

(f) Impairment of Assets

At each balance sheet date, the Institute reviews the carrying amounts of its assets (other than inventories and deferred tax assets), to determine whether there is any indication that those assets have suffered an impairment loss. If such indication exists, impairment is measured by comparing the carrying values of the assets with their recoverable amounts. Recoverable amount is the higher of net selling price and value in use, which is measured by reference to discounted future cash flows. Recoverable amounts are estimated for individual assets or, if it is not possible, for the cash-generating unit to which the asset belongs.

An impairment loss is charged to the income statement immediately. Reversal of impairment losses recognised in prior years is recorded when there is an indication that the impairment losses recognised for the asset no longer exist or have decreased. The reversal is recognised to the extent of the carrying amount of the asset that would have been determined (net of amortisation and depreciation) had no impairment loss been recognised. The reversal is recognised in the income statement immediately.

(g) Income Recognition

Subscription income is recognised on a receipt basis.

(h) Cash and Cash Equivalents

Cash comprises cash in hand, at bank and demand deposits. Cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to insignificant risk of changes in value.

3. FINANCIAL RISK MANAGEMENT POLICIES

The Institute's financial risk management policy seeks to ensure that adequate financial resources are available for the development of the Institute's businesses whilst managing its risks. The Institute operates within clearly defined guidelines that are approved by the Board of Committee and the Institute's policy is not to engage in speculative transactions.

The main areas of financial risks faced by the Institute and the policy in respect of the major areas of treasury activity are set out as follows:-

(a) Credit risk

This is the risk that a counter party is unable to pay its debts or meet its obligations.

The credit risk attributed to receivables is mitigated by the application of internal credit review procedures.

(b) Liquidity and cash flow risks

Liquidity or funding risk is the risk of the inability to meet commitments associated with financial instruments while cash flow risk is the risk of uncertainty of future cash flow amount associated with a monetary financial instrument.

As part of its overall prudent liquidity management, the Institute maintains sufficient levels of cash and cash equivalents to meet its working capital requirement.

The Malaysian Government has implemented various containment measures in order to curb the spread of Covid-19 including Movement Control Order ("MCO"), Full MCO and Enhanced MCO (or total lockdown).

In June 2021, the Malaysian Government unveiled the four-phase National Recovery Plan whereby movement control measures will be gradually eased as Malaysia moves from one phase to the next.

On 1st April 2022, the Malaysian Government announced that Malaysia will transition to the endemic stage with all restrictions on business operating hours removed.

The Company has considered the impact of Covid-19 in the application of significant judgements and estimates to determine the amounts recognised in the financial statements. Given the fluidity of the situation, the Company will continue to monitor the impact of Covid-19 and take appropriate and timely measures to minimise its impact on the company's operations.
